1. Supplemental Data
  - a. Folks are making progress – I'll keep this item on the agenda for the foreseeable future as a check-in
2. Table Updates/clarification
  - a. MIS Language code – uncoded MIS – means you are can't locate the language. This is not to be used interchangeably with UND Undetermined
  - b. Return to Inpatient/ Revocation Authority when DCR Invest Outcome = 4. It is the Outcome of 4 that requires there be an answer in the Revoke field. There was an error in the state processing that was causing rejections to the records. We are working with the State to resolve – you won't need to resubmit records
3. Data Dictionary Clarification
  - a. This is a standing option to be sure the Data Dictionary is understood and to keep a time on the agenda to ask any questions.
